THE JUDICATURE ACT, No. 02 OF 1978

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Judicature Act, No. 2 of 1978, I, Rauff Hakeem, Minister of Justice in consultation with the Chief Justice and the President of the Court of Appeal, do by this Order, amend the Order published in *Gazette Extraordinary* No. 1679/40 of November 10, 2010 as follows :
