ORDER UNDER SECTION 3

THE JUDICATURE ACT, No. 2 OF 1978

By virtue of the powers vested in me by section 3 of the Judicature Act, No. 2 of 1978, I Wijedasa Rajapaksha, Minister of Justice in consultation with the chief Justice and the president of the Court of Appeal, do by this Order, amend the Order published in the *Gazette Extraordinary* No. 1679/40 of November 10, 2010 as last amended *Gazette Extraordinary* No. 1890/17 of November 26, 2014 as follows;

- (1) by the substitution for the words "Thirty Three Judicial Zones" of the words "Thirty Four Judicial Zones";
- (2) in the Schedule thereto :-
 - (i) by the substitution for the entry "Avisawella" appearing in Column I under the heading "Zone" and its corresponding entry in Column IV under the heading of "Area of Jurisdiction" of the following entries respectively :-

"11. Avisawella	The Judicial Zone of Avisawella shall comprise the Judicial Districts of Avisawella and Ruwanwella.";
